Clubhouse Rules:

- 1. No smoking is allowed in the clubhouse.
- 2. No alcohol sales of any type are allowed.
- 3. No pets are allowed inside the clubhouse.
- 4. No equipment or furniture may be removed from the clubhouse.
- 5. All trash must be deposited in the yard dumpster.
- 6. Food items are not to be left in the refrigerator or freezer.
- 7. All Events must provide their own supplies. Existing supplies are reserved for the SPYC Social Committee (I.e. paper products, plastic ware etc.).
- 8. The clubhouse is to be left in good condition and clean after each use. (The Member responsible for the Event or Rental will be assessed for any unusual cleaning, repair or replacement costs)
- 9. Event or Rental Items may not be left or installed in the clubhouse without SPYC Clubhouse Committee approval.
- 10. Events shall not limit usage of the Bathrooms, Showers & Utility rooms to SPYC Members, Associate Members and their guests.

Clubhouse Usage:

SPYC Members, Associate Members and Employees may use the SPYC clubhouse for private events, subject to Clubhouse rules, ordinances and state law. The Clubhouse is a benefit to SPYC Members. The private usage should be reflective of that and shall be restricted to members, their family and friends. Exceptions must have SPYC Board approval.

- Usage fee will be charged for all private parties held in the clubhouse. Please refer to the SPYC Clubhouse Event Type for usage fees.
- Reservations will be honored by usage fee paid date and may be requested through the SPYC Manager.
- No commercial or political usage is allowed by Member Private Events.

SPYC Clubhouse Event Types:

(All Member Events must be sponsored by a SPYC Member or Associate Member)

- Member Event Spontaneous
 - Description: SPYC Member or Associate Member sponsored event for Members (Let's watch the Vikings/Packers/Wild/Blackhawks/Kentucky Derby/Super Bowl, etc.)
 - Board Approval Required: No. Subject to availability.

Usage Fee: None

Member Event - Club

- Description: SPYC Member, Associate Member or Employees event where they invite all Members. Members may or may not attend. Similar to a Social Committee event, but sponsored by a Member. (Birthday, Booyah, Martini's, TGIF, etc.)
- Board Approval Required: Yes
- Usage Fee: None

• Member Event - Private

- Description: SPYC Member, Associate Member or Employees private event for friends and family. Exclusive of members.
- Board Approval Required; No
- Usage Fee:
 - o 20 people or less: \$75 Member, \$125 Associate Member
 - o 20 people or more: \$125 Member, \$175 Associate Member

Member Event - Outside Interest

- Description: SPYC Member or Associate Member sponsored meeting or event for another entity (Friends of Pool 2, Concerts, Cultural, Charitable, Non-Profits, Business meeting, etc.)
 - Outside Interest must promote safe and affordable boating on the Mississippi river.
- Board Approval Required: Yes
- Usage Fee:
 - Meetings
 - 20 people or less: \$10020 people or more: \$150
 - Event or Party
 - 20 people or less: \$17520 people or more: \$275

Outside Organization – No Member Sponsorship

- Description: Business meeting or event request from an outside organization (Coast Guard, Department of Natural Resources, St. Paul Fire & Police, County Sherriff, Cultural, Charitable, Non-Profits, etc.)
 - Outside Organization must promote safe and affordable boating on the Mississippi river.
- Board Approval Required: Yes
- Usage Fee:
 - Meetings
 - 20 people or less: \$15020 people or more: \$200
 - Event or Party
 - 20 people or less: \$25020 people or more: \$350
 - Custom Depending on Date, Time or Number of Occurrences
